

## Torres Strait Regional Authority (TSRA) and Australian Maritime Safety Authority (AMSA) joint Indigenous Paint Scheme for AMSA's Search and Rescue Aircraft

### EXPRESSION OF INTEREST

The Torres Strait Regional Authority is inviting Expressions of Interest from Torres Strait and Aboriginal artists to submit artwork images for the joint TSRA and AMSA.

**Application Closing date:** 4:00pm on Friday 18 March 2021

#### Eligibility Criteria:

- Torres Strait Islander and Aboriginal person/s
- Artists aged 18 years and older, that live in the Torres Strait and Northern Peninsula Area.
- All Artists (from hobbyists to established) in from all communities are encouraged to apply. Multiple artwork submissions are encouraged.
- Existing Gab Titui Cultural Centre registered artwork may be considered; however, artists must specifically request its usage via this formal EOI process.
- Artist must hold copyright on artwork submitted; and artist must declare whether any artwork submitted has existing or previous licence agreements.

#### What to submit:

- A completed application form (attached)
- Story and Details of Artwork/s
- Support material ie. digital image/photographs of your artwork
- Submissions are sought for images/artworks that are of suitable form and content to be printed on public signage, that reflect Torres Strait art, culture and/or lifestyle.

#### If an artwork is selected – what next?

- Artist/s will work with TSRA and AMSA to finalise their selected artwork against the requirements of the project.
- Selected artwork will be licenced on a non-exclusive basis, including the appropriate payment of a fee for use.

The application form is to be mailed/emailed to the TSRA by **4pm, Friday 18 March 2022**.
